Re: Fiscal Year 2022 Cook County Health Budget

Dear Cook County Health Board of Directors:

I am writing to highlight the innovation that exists within the Cook County Health (CCH) system.

The COVID-19 pandemic has exacerbated food insecurity for children and families in under-resourced communities throughout Cook County. In an effort to help solve this problem, CCH has joined forces with Top Box Foods, a nonprofit organization that creates access to healthy foods in under-resourced and underserved communities. CCH and Top Box Foods came together to develop an innovative pilot program designed to improve the nutrition and physical activity of youth and their families through increased access to healthy, affordable food. The Chicago Youth Text28Healthy Project, will serve the families of 35 Cook County Health pediatric patients of color who are overweight and experiencing food insecurity. Top Box Foods will deliver weekly grocery boxes of fresh fruits and vegetables, proteins, and whole grains for a 6-month period, providing nutritious dinners for each patient and their family for 5 days per week.

To nudge participants toward long-term healthy behaviors, a Top Box Foods nutritionist will facilitate weekly dietary educational sessions as well as a text message initiative that will communicate nutrition information, culturally appropriate recipes and cooking lessons, and physical activity challenges that will be tracked by a Fitbit, provided for each participant. BMI Z scores, validated food questionnaires, and a physical activity questionnaire will also be used to measure outcomes.

The program is supported by a \$125,000 award from The Cigna Foundation as a part of Cigna's Healthier Kids For Our Future initiative, which supports community programs addressing 3 of the United Nations Sustainable Development goals: No Poverty, Zero Hunger, and Good Health and Well-Being.

As one of the largest public health and hospital systems in the United States, I commend CCH for its collaborative work. We at Top Box Foods look forward to this partnership and believe that the demonstration of improved outcomes in eating practices and exercises will enable us to to scale this program to other areas, and ultimately create a healthier and more vibrant Cook County resident.

Dr. Charmoniquε Tims. NMD I am Beulah Brent, the Chief Executive Officer of Sisters Working It Out (SWIO) and a former Manager in the department of Radiology/Mammography at John H. Stroger Hospital. My work at Stroger Hospital and at other healthcare organizations helped to fuel my passion for breast cancer and community health awareness. These lived experiences strongly influenced my decision to take on the important work of CEO at SWIO to help African American women experiencing breast cancer to improve their survival rates.

Throughout its 19-year history, SWIO has worked tirelessly to address the many barriers contributing to high breast cancer mortality rates for African American women, such as lack of health information, mistrust of providers and health systems, and limited access to primary care and breast cancer screening through services like mammograms and clinical breast exams. Across the United States survival rates for early-stage breast cancer are close to 100%. Yet, African American Women in Chicago are 40% more likely to die from this disease.

Part of the mission of Sisters Working It Out is accomplished through providing programs to educate and empower women of color as well as connect them to quality preventive health services. With Provident Hospital's long-standing history on the South Side of Chicago, SWIO refers African American women living in the area for breast cancer screening and mammograms. We are grateful to Cook County Health for the addition of the modern Mammography studios that were added a few years ago at Provident Hospital and help women who visit there to feel more at ease. I am also happy with the addition of ambulance runs and the re-establishment of ICU services at Provident. These services, in conjunction expansion of ophthalmology, hemodialysis and surgical services with the great primary care provided at the Sengstacke Health Center within the hospital, help people better their health in a holistic way. I know firsthand that the staff in the department of Radiology/Mammography at Provident Hospital make a difference every day in the lives of their patients.

Finally, the past year during this Covid-19 pandemic has been a chaotic one. Sisters Working it Out is also proud to have joined forces with Cook County Health and the Cook County Department of Public Health to raise awareness about Covid-19 vaccination and prevention through education and programming. We have hosted many events in the Southland and shared resources with partners. Kudos to CCH and CCDPH on their vaccination programming.

Overall, Sisters Working it Out is supportive of Cook County Health's budget. Growing programs that benefit those who need help presents the great work being done in the healthcare arena.
