## Job Summary

The Medical Technologist I, performs transthoracic echocardiograms as well as obtains images for transesophageal (TEE) and stress echocardiograms; performs routine and emergency electrocardiograms (ECG), as requested by the physician and in accordance with standard practices; and prepares patient records for review and interpretation by the physician and maintains confidentiality. The incumbent is responsible for maintaining equipment and all necessary supplies. and participates in quality improvement activities.

#### Typical Duties

- · Provides interpreting physician, through the noninvasive diagnostic imaging techniques of ultrasound, a complete and accurate documentation of cardiac anatomy and cardiac performance for adult patients.
- Performs routine and emergency electrocardiograms (ECG) as requested by physician, and in accordance with standard practices; use aseptic techniques.
- Performs routine and complex ambulatory monitoring studies as requested by physician and in accordance with standard practices; use aseptic techniques.
- Performs routine and emergency non-invasive cardiovascular procedures; use aseptic techniques.
- Performs routine, complex, and emergency echocardiograms, including but not limited to: dobutamine echocardiograms, tilt table, transesophageal echocardiograms, and stress testing, as requested by physician and in accordance with standard practices, use aseptic techniques.
- Administers IV contrast and agitated saline as needed for echocardiographic studies
- Analyzes patient's medical records to obtain history of symptoms and necessary information for performance of diagnostic procedures.
- Prepares patient records for review and interpretation by physician, including the selection, recording, cross-referencing of significant or representative studies.
- Maintains confidentiality of patients, employees, and corporation-related activities.
- Participates in quality improvement activities by evaluating procedure results for technical quality and accuracy and maintain appropriate logs, files, and records.
- Maintains equipment in working order, making minor adjustments and repairs, performing routine cleaning and preventative maintenance; reports equipment malfunction to department manager.
- Maintains all necessary supplies (ordering and stocking).
- Performs as a member of the cardiac arrest team; assists in emergency situations by initiating and/or assisting in emergency procedures prescribed by hospital policies.
- Maintains certification in Basic Cardiac Life Support procedures.
- Instructs students, nurses, or other allied health personnel as requested.
