Job Summary

The Nurse Coordinator II oversees all aspects of patient care within the Endoscopy unit, on a 24 hour basis by evaluating, directing, and supervising all activities of the nursing staff. This position has first line responsibility for clinical and personnel management, patient care, budgeting, and quality service delivery for the unit.

This position is exempt from Career Service under the CCHHS Personnel Rules.

General Administrative Responsibilities

Collective Bargaining

- Review applicable Collective Bargaining Agreements and consult with Labor Relations to generate management proposals
- · Participate in collective bargaining negotiations, caucus discussions and working meeting

Discipline

- Document, recommend and effectuate discipline at all levels
- Work closely with labor relations and/or labor counsel to effectuate and enforce applicable Collective Bargaining Agreements
- Initiate, authorize and complete disciplinary action pursuant to CCHHS system rules, policies, procedures and provision of applicable collective bargaining agreements

Supervision

- Direct and effectuate CCHHS management policies practices
- Access and proficiently navigate CCHHS records system to obtain and review information necessary to execute provisions of applicable collective bargaining agreements

Management

- Contribute to the management of CCHHS staff and CHHSS' systemic development and success
- Discuss and develop CCHHS system policy and procedure
- Consistently use independent judgment to identify operational staffing issues and needs and perform the following functions as necessary; hire, transfer, suspend, layoff, recall, promote, discharge, assign, direct or discipline employees pursuant to applicable Collective Bargaining Agreements
- Work with Labor Relations to discern past practice when necessary

Typical Duties

- Assures the direct nursing care to patients is delivered utilizing the nursing process and evidence based practices.
- Provides direction, coordination and evaluation of patient care. Demonstrates skill in the coordination and the management of a patient care unit.
- Supervises nursing and ancillary staff, may perform clinical procedures in the event staffing is compromised due to absenteeism, incidents occur, or needs arise.
- Develops and maintains goals and objectives, standards of practice, policy and procedures and written job descriptions for all personnel within the confines of the Endoscopy unit.
- Assures staff administer medications and performs endoscopic procedures as directed by the physician under the guidelines of the Illinois State Board of Nursing.
- Continually evaluates efficiency in health care delivery system.
- Routinely reviews and updates patient education and as needed.
- Provides for staff development and in service education using evidence based practices.
- Evaluates staff performance annually, initiating training or a performance improvement plan when warranted.
- Develops and coordinates area specific orientation schedules for new staff.
- Assumes responsibility and initiative for problem solving and decision-making with staff and appropriate others.
- Schedules daily staffing, vacations, sick leaves, and other benefit time.
- Manages Endoscopy infection prevention program.
- Manages Endoscopy fire / safety program and ensures a safe environment for patients and staff.
- Accountable for assuring staff maintain current licensure and certifications (i.e. Illinois license as a Professional Nurse, BLS, and ACLS).
- Assures that the staff of Endoscopy are compliant in all mandatory requirements; such as but not limited to annual training, flu vaccine, and dual employment, infection control, etc.
- · Assures managerial coverage and handoff during their absence.
- Follows the EPO policy, participates in training when as necessary. Interviews applicants, makes selections, and processes documents as required meeting determined timelines.
- Follows and implements disciplinary action when required according to policy in a timely manner.
- Maintains records, reports and logs as required by accrediting agencies specifically the Joint Commission. Ensuring compliance with federal, state and county guidelines.
- Assists with planning, implementing and maintaining the quality assurance program for Endoscopy.
- Develops and maintains quality assurance through quarterly reporting for adverse outcomes and time studies.
- Develops and oversees logs used to evaluate equipment usage.
- Reports broken or deteriorated equipment. Makes budgetary projections and procures essential supplies and equipment to assure seamless provision of services.
- Conducts daily rounds, communicating with patients, their families and staff; troubleshooting issues as they are reported.
- Ensures nurses understand and are compliant with CBA's for all employees in Endoscopy.
- Responsible for driving the CCHHS culture through values and customer service standards
- Accountable for outstanding customer service to all external and internal customers.
- Develops and maintains effective relationships through effective and timely communication.
- Takes initiative and action to respond, resolve and follow up regarding customer service issues with all customers in a timely manner.
