## Job Summary

The Infection Control Consultant develops, implements, and evaluates the hospital wide infection prevention and control program including healthcare associated infection surveillance; management of influx of potentially infectious patients; cleaning and disinfection of environment, medical equipment, devices, and supplies; antibiotic stewardship; and policies and procedures that adhere to nationally recognized guidelines, under guidance and as directed by the department. Oversees the infection prevention and control program management and planning for Joint Commission Accreditation and accreditation related activities for Provident Hospital including underlying clinic and dialysis unit. Sets guidelines to meet requirements for Joint Commission Accreditation leading to successful accreditation for all entities within the hospital. Reviews and maintains a comprehensive accreditation plan adhering to standards, prioritized interventions and on-going monitoring for compliance as established by Joint Commission for all accreditation requirements. Reviews and manages a plan to assure compliance with Centers for Medicare and Medicaid Services (CMS) Conditions of Participation. Coordinates efforts with primary stakeholders to assure regulatory compliance with standards.

## **Typical Duties**

- Develops and leads a regulatory survey readiness program related to infection prevention and control in support of the organization's mission, values and business objectives
- Monitors and updates the infection prevention and control plan based on risk priorities, as needed
- Implements the infection plan prevention and control plan using evidence-based national guidelines
- Evaluates the infection prevention and control plan, communicates findings to stakeholders and revises plan as needed
- Establishes guidelines to meet Joint Commission accreditation requirements for infection prevention and control
- Develops and maintains an infection prevention and control project plan linked to standards with on-going monitoring and reporting to senior management
- Serves as the infection prevention and control resource in questions related to Joint Commission accreditation and to CMS standards
- Works with senior management and clinical staff in leading and managing infection prevention and control related accreditation process and standard adherence
- Coordinates infection prevention and control activities with subject matter experts and unit business owners
- Conducts training and coaching to support understanding of accreditation standards and requirements related to infection prevention and control

### **Typical Duties**

- Develops and maintains plans to assure compliance with regulatory requirements related to infection prevention and control
- Develops and manages audit activities to ensure compliance with infection prevention and control accreditation standards and develops and maintains a dashboard to demonstrate ongoing compliance
- Facilitates communication of information among governance committees and serves as liaison on accreditation issues and changing standards
- Maintains accreditation and audit document library
- · Performs other duties as assigned

- Current work experience and knowledge of Joint Commission standards and the Centers for Medicare and Medicaid Services Conditions of Participation regulations
