Scans are needed for a complete structural analysis of the existing roofing system and structural integrity. Imaging is an essential element in the predictive maintenance of a multimillion-dollar roof asset, and essential to illustrate moisture infiltration and migration in the field of a roof, and can aid in planning for life cycle budgets and provision for remediation.

4	Attachment T: Scope of Work	We assume all roofs and elevations will require a davit/tie-back system; please confirm if that is correct.	The project includes the review and design for roof davit supports and tieback system around the existing Provident Hospital building.
5	Attachment T: Scope of Work	Are you looking for specific load verification testing of the existing davits?	Yes. Testing shall be determined during the evaluation phase.
6	Attachment T: Scope of Work	What is the existing roof system & structure? Could roof framing plans be provided for reference?	This information will be provided to the Awardee.
