During my time here at Provident, I have seen numerous resources being taken away from the hospital without any logical explanations. Now, in the middle of a global pandemic, the plan of making Provident ER into " a standby ER" or " urgent care facility" is very upsetting. COVID-19 has 19 disproportionately affected Black Community and now they need us more than ever before. The plan of closing Woodlawn and Near South Health Centers and merging it with patients at John Sengstacke Clinic at Provident Hospital will ONLY bring more patient into Provident ER. Every day we get multiple patients sent down form the clinic to the ER due to either their blood pressure or blood sugar is too high. Those patients need higher lever of care that the clinics can not provide.

Cutting down providers in the ER will only endanger patient lives. Patients would be waiting in the ER much longer to be seen by a provider. With the news of Mercy Hospital closing early next year, Provident ER volume is only going to go up. Recently during my shift, I have seen a DKA patient requiring ICU admission, patient with a large neck mass compressing his airway, COVID positive patient requiring hospitalization and many patients with COPD/asthma flare ups that needed the higher lever of care that the ER was able to provide for them. Where will these patients go??
