1	4/19/2022	Will the grant support training of new CHWs?	Community Health Worker (CHW) is listed twice in the RFP: Under funding option #1, the CDC National Initiative to address COVID-19 Health Disparities and under option #3, the CDC CHWs for COVID Response and Resilient Communities. Both options should allow for training, but please read through the RFP to see which best aligns with your organization's goals.
2	4/19/2022	Are hospitals with CHW Programs eligible to apply?	Hospitals are not eligible to apply for direct funding. Eligible applicants include community health centers, including Federally Qualified Health Centers (FQHCs), FQHC lookalikes, free clinics, and mental health centers. Hospitals are encouraged to partner with eligible applicants.
3	4/19/2022	Under CDC Equity, can we apply for both CAWS and Covid 19? Or do we have to choose 1? What are parameters for applying for more than one?	Eligible applicants may be able to apply for more than one strategy under a funding source as well as apply to multiple funding sources. Be sure to align your work plans and budgets accordingly with regard to whichever option(s) you choose. The appendices layout the work plans by funding source as well as the budgets by funding source. Read those sections closely to ensure you submit the correct information.
4	4/19/2022	Regarding eligibility for multiple funding streams, per Gina's comments earlier: Are eligible organizations able to submit multiple applications for this particular RFP (0027) for more than 1 of the 4 funding streams detailed earlier (CDC Health Equity, ARPA, CDC CHW, IDPH COVID-19 Crisis)?	You do not submit more than one application. We braided the funding and we have one RFP is so that applicants who are eligible for more than one strategy on the menu of options across funding sources will be able to check each one for which they choose to apply in a single application. However, you will need to provide a separate work plan and budget for each respective funding source. Please note that for ARPA, you will need to submit a budget per strategy you choose.

The Suburban Cook County RFP is H22-0027, and the City of Chicago RFP is H22-0028. Please note these are two separate opportunities with their applications and review processes.

Applicants can use the following information to account for local travel expenses as part of their budget(s): 4 RLAN meetings and up to 60 miles per meeting per person at a federal mileage reimbursement rate of \$.585 per mile.
7	4/19/2022	Are slides available?	We will provide the recordings of each information session as well as the FAQs. These will be uploaded to the Bids & RFPs webpage. If you have registered to download the RFP, you will receive the link via email once new materials are available. The info sessions have been added to the website.
8	4/19/2022	Is there a MBE/WBE requirement?	The MBE/WBE participation goal is 0% participation. However, please include a utilization plan if your organization decides to utilize an MBE or WBE firm.

Under the ARPA funding, we will have a process for applications to be reviewed individually as well a panel review process using a decision-making framework to support our selection. Is this true for all categories, or is there an exception for food insecurity?	Overall, food is not an allowable expense. However, applicants who select the food security strategy under ARPA may use funds to purchase food if the recipients are individuals/households that experienced unemployment, increased food or housing insecurity, or are lower/moderate-income who experienced a negative economic impact from the pandemic. The use of funds for food for the ARPA - food security strategy should be reflected in the proposed budget.

However, because it's a relatively new CHW program, it is difficult to obtain letters of commitments from health care providers not having a proven track record of producing CHWs for hospitals or home health care. Is there any way to submit a CHW funding request without the letters of commitment from prospective employers if we are partnering with UIC Ocean or SUHI on the training?	Letters of commitment are required as part of the proposal. A proposal without the required letters of commitment will be considered incomplete. We encourage applicants to consider organizations that they can collaborate with to maximize the impact of their project. As for the Community Health Worker strategy funded as part of the CDC National Initiative to Address COVID-19 Health Disparities and CDC Community Health Workers for COVID-19 Response & Resilient Communities, technical assistance partners include Health & Medicine Policy Research Group/Sinai Urban Health Institute and UIC Office of Community Engagement & Neighborhood Health Partnerships (OCEAN-HP).

The organizations do not have to be in suburban Cook County. A site in Oak Park is eligible for funding.

Each organization must identify three (3) people who will be able to work on this project. One would be your lead person, and then 2 (two) alternate individuals in case we are unable to contact the lead person. These contacts alternates are not from CCDPH; they are from your organization. Note, if the application asks you for an email address on the application, please list a valid email address, do NOT list xxx; you will receive an error message. The same goes for phone numbers.

6	Other	4/19/2022	Eligible Applicants. Where only a CBO is designated, are FQHCs and community mental health centers excluded? In particular, we're looking at 2. ARP Fiscal Recovery Funds- Mental Health Strategy. We want to propose implementation of a peer-led, community mental health support program, We are a community-based organization that is also an FQHC and CMHC. Are we eligible?	No, FQHCs or Community Health Centers may not apply for funding where it indicates Community-based Organizations (CBOs) as eligible applicants. FQHCs and mental health centers may apply for strategies that identify Community Health Centers as eligible applicants.
