

# Residencies/Fellowships

- Accreditation Council for Graduate Medical Education (ACGME)
  Declared Three Stages
- Stage 1 Normal
- Stage 2 Increased Clinical Demands, but Education is Continuing
- Residents may be reassigned (Notify Designated Institutional Official)
  - Must Have Appropriate Supervision, PPE and COVID Training
  - Fellows can be deputized as attendings for 20% of the year (ten weeks)
  - No change in Duty Hours
  - If Educational Activities are disrupted for >30 days, must notify the RRC
- Stage 3 –Educational Activities Have Ceased and All Programs Are Shifted to COVID Care

- Re-deployed residents from specialty services to MICU and COVID units
- Increased resident pool in the Emergency Department
- Fellows credentialed as Attendings in their area of board certification
