

- Cultivates partnerships through regional convenings and participation in community collaboratives and events
- Supports 27 funded partners:
 - **Promotes social/emotional learning, mentorship**
 - 88% of Southland youth engaged in Big Brothers Big Sisters program said they increased self-regulation and emotional management
 - **Creates safe spaces** such as Latina Women's Support Group (Hoffman Estates) and Queer Prom (KYC)
 - Provides **mental health treatment and education**
 - Provided telehealth visits for youth (South Cook ISC)
 - Hosted sessions on executive functioning for teens and parents (Pillars Community Health)





Suicide Prevention



Crisis Care System

“Before today none of us had even heard of 988. If it works like you say, it sounds great, but I still worry they might take us to jail instead.” — *Community member*

“We’re listed as a 988 crisis provider and offer Mobile Crisis Response but sometimes calls meant for 911 wellness checks get mishandled. It’s critical these services coordinate clearly.” — *Provider*

Focus groups were held with community members and providers as part of a strength and needs assessment of the suburban Cook County crisis system.





Crisis Care System

- Increase awareness of 9-8-8 in the community using outreach through trusted community leaders, organizations, and institutions.
- Improve access to culturally responsive crisis care in all regions of suburban Cook County.
- Improve coordination between service providers for smooth transitions of care and “no wrong door” entry points, in coordination with CESSA oversight bodies, and balancing regional assets and needs with consistency across the state.
- Invest in diversification and a reinforced crisis workforce
- Create systems for ongoing aftercare support and engagement, including opportunities to address social determinants of health

Opioid and Substance Use Prevention

- Distributes naloxone and test strips to community organizations through CCDPH's distribution program and funded partners.
 - Since December 2020, at least 186 naloxone doses have been used in an overdose events.
- Provides free trainings on how to recognize and respond to an opioid-involved overdose
- Supports four funded partners to expand harm reduction services in suburban Cook County
- Produces analysis of opioid risk factors, harms, root causes, and opportunities to influence policy and systems change





Summary

- Peak-and-decline across ages:** Admission rates spike in 2016–2017 for every age group (highest in 25–34), then decline steadily through 2022; counts mirror this fall.
- Opioid-involved hospital admissions concentrates in midlife:** After 2016, 35–44 and 45–54 maintain the largest proportions of hospitalizations, even as their rates fall.
- Youth and older adults diverge:** 15–24 drops sharply in both rate and share after 2016, while 55–64 (and to a lesser extent 65+) retain a meaningful and slightly rising proportion.
- No pandemic rebound in admissions:** Unlike emergency department visits, hospitalizations continue to fall through 2020–2022, consistent with heightened admission thresholds.

Overdose Prevention Sites

Based on the scientific literature, Cook County Department of Public Health has found that Overdose Prevention Sites (OPS) are a vital harm reduction strategy with clear public health benefits

Government-sanctioned OPS started in the 1980s as places for people who use drugs to inject heroin, cocaine, and other drugs under the supervision of medical personnel. OPS are a harm reduction strategy that aims to reduce overdose deaths and other harms from drug use. Over 100 sites now exist across the globe.¹ Scientific studies published in peer-reviewed journals have demonstrated that OPS decrease overdose deaths and suggest that OPS also reduce the transmission of HIV, Hepatitis C, and other blood-borne infectious diseases. OPS also connect people who use drugs (PWUD) to substance use disorder (SUD) treatment programs.²

Based on the scientific evidence, Cook County Department of Public Health (CCDPH) believes that OPS are a vital harm reduction strategy with clear public health benefits. Harm reduction services in CCDPH's jurisdiction of suburban Cook County are few and far between, and there is a need for OPS and expanded harm reduction services in the suburbs.

Medical professional organizations have also supported OPS. In 2017, The American Medical Association endorsed the development of pilot OPS as part of a comprehensive strategy to address synthetic and injectable drugs. In its statement, the American Medical Association cited research on the reduction in overdose deaths and disease transmission, and the increase in people starting substance use disorder treatment as a result of OPS.³ The American Society of Addiction Medicine also released a statement of support for OPS, further arguing for their necessity given the surge in drug overdoses during the COVID-19 pandemic.⁴

Both Cook County State's Attorney Kim Foxx and Illinois Attorney General Kwame Raouf have expressed support for OPS.⁵ State's Attorney Foxx traveled with a delegation of Illinois advocates to Toronto to visit an overdose prevention site in June 2019, and later signed a legal brief in support of a proposed overdose prevention site.⁶ Building upon the growing support for innovative solutions to the opioid epidemic, Governor Pritzker issued an executive order calling for the implementation of programs that may promote safer drug use and prevent drug overdoses.



