Frequently Asked Questions and Answers

This resource has been prepared by Cook County Health (CCH) to answer questions about the Stronger Together grant opportunity. This document will be updated during the duration of the application process, with updated content deriving from submitted questions to the email below and during Information Sessions and Workshops. Questions have been consolidated and adapted for clarity, and questions pertaining to specific proposed programs ideas are not included.

	Are there character/word limits for the narrative sections?	No, there is no character limit.
Application Portal	Can we submit additional documents to provide more information about our organization?	No, the only documents that reviewers for this grant will consider are the Application, Work Plan and Budget templates provided. Please do not attach or submit additional documents. This grant application does not require a cover letter or letters of recommendation.
	Can you save the application and come back to work on it?	No, you will need to fill out your organizational information and upload your offline documents in one-go.
	When submitting at GovGrants, which email addresses will receive the "application successfully submitted" email notification (Exc. Dir./CEO, Project Director/Manager, Authorized Representative)?	The Authorized Representative will receive the email confirmation.
	Who will be recruited as review team members to evaluate the proposals?	Members from the Office of Behavioral Health, Cook County Health, and Cook County will be involved in the review process.
	Can you provide a comprehensive list of all documents needed for the application	ApplicationWorkplanBudget and Budget Narrative
	We also have a fiscal agent; can you confirm if that fiscal agent will also need to provide any documents?	The fiscal agent does not need to provide documentation.
	Do you request that the application uses a specific font?	No, we do not have font requirements. However, we ask that all text be legible.
	Does each organization have to be approved to use Salesforce?	No, each organization does not need to be approved to use Salesforce to apply.

Application Portal (continued)	Could you please direct me to the CFDA number associated with the Stronger Together funding opportunity?	The CFDA for ARPA is 21.027.
Application Fortal (continued)	Privately funded organization, do we need to list the private grants?	No, please only list government grants.
	Should the attachments be submitted in the form they are presented as? Or should they be converted into PDFs	We ask that they are uploaded the same way they were downloaded.
	Can we be somewhat broad and just provide the name of the funder for funder history, such as HRSA? As an FQHC, we typically have 4-6 HRSA grants annually. Or do you want the names of each grant we received?	Please provide the name of the funder and the name of each grant.
	Would a single audit be required?	An audit will not be required for the application. However, for those organizations that are funded the Office of Behavioral Health will work with them to complete an ARPA Risk Assessment and Federal Award Audit Detail that will ask for an audit.
	How long do we have to complete the application in the portal before it times out?	Please upload your offline documents in one-go, then complete the organizational information in the portal.
	We're applying for the Stronger Together grant when it opens and are trying to acquire a UEI number in preparation. We are experiencing challenges in entity validation as a first step to registration, however, and we're wondering if there is any technical assistance available for going through the registration process?	Unfortunately, we are unable to provide any technical assistance for acquiring a UEI number. The SAM.gov website provides a service desk service. GSAFSD Service Portal Landing - GSA Federal Service Desk Service Portal
	Would you speak to, or describe the technical assistance providers, the type of technical assistance that will be provided, and when?	The Office of Behavioral Health will be providing technical assistance as needed by the partners. Technical assistance could include but is not limited to program development, monitoring and reporting, fiscal management, and sustainability.
	We have already submitted our application for 5013c NFP organization, and was told it will take 2 weeks for the approval process, can we still go ahead and apply for the grant?	Only applicants that are 501(c)(3) eligibility and fall under the applicant eligibility criteria as listed in the information packet by April 17th are eligible to apply for this grant.

Category	Question	Response
Application Portal (continued)	If our SAM ID is expiring in August, should we renew it now, or should we wait until August to renew it?	We recommend renewing sooner rather than later in case of unexpected delays in processing, but you do not need to renew before applying for the Stronger Together Open Call.
	Where in the application do we complete the risk assessment?	The risk assessment is not part of the applicationorganizations that are awarded funds will then be guided through the risk assessment process.
	Do we need to attach a copy of our NICRA for our application submission?	No, however, you will need to describe your NICRA in the budget narrative section of the indirect cost budget category. If selected for this grant, you will need to provide all of your relevant NICRA documentation to the program team prior to executing your legal agreement.
	If we have letters of recommendation, where is the appropriate place to send them?	The Office of Behavioral Health is not accepting letters of recommendation for this open call.
	If selected, how do we submit our expenses?	All subrecipients will submit their expenses through GovGrants. Financial reporting and compliance training will be provided prior to the launch of the grant.
	Can more than one person have access to the portal where we submit the expenses?	Yes, more than one person can have access to GovGrants.
	Will the information session slide deck and recording be shared?	Yes, recordings and slide decks from the information sessions and capacity building workshops will be posted on https://cookcountyhealth.org/strongertogether/ after they are complete.
Information Sessions and Capacity Building Workshops	When are the information sessions and how will I be able to access them?	The information sessions were held on Friday, March 8 th and March 13 th . You can access the meeting link at <u>Stronger Together: Building a More Equitable Behavioral Health System – Cook County Health under Information Sessions.</u>
	When are the capacity-building sessions and how will I be able to access them?	The capacity building workshops will be held on Wednesday, March 20 th Friday, March 22nd, Wednesday, March 27 th , Friday, March 29th, Wednesday, April 3 rd , and Friday, April 5 th . Category	Question	Response
Eligibility – Organization Type/ Service Line	Are Community Mental Health Centers (CMHCs) that are part of a larger health system eligible?	Yes, if the center is a registered 501(c)(3) at the time of submission.
Service Line	As a skilled home health agency serving mental health patients, are we eligible for this?	Yes, if the agency is a registered 501(c)(3) at the time of submission.
	Are institutions of higher education eligible to apply?	Yes, higher education institutions are eligible if they maintain 501(c)(3) status.
	Are centers based at universities eligible to apply if they are 501(c)(3)s?	Yes, if the center is a registered 501(c)(3) at the time of submission.
	Do applicants have to be 501(c)(3) non-profit entities and GATA certified? Could a higher education-affiliated entity that is GATA certified but not a 501(c)(3) apply? If the entity is in the process of attaining not-forprofit status at the time of application, is this sufficient?	This grant uses Federal funds from the American Rescue Plan Act. GATA certification is not required by 2 CFR 200, also known as Uniform Guidance. For this grant, 501(c)(3) status is required. Higher education entities and affiliates must have 501(c)(3) status to be eligible. Lead applicants must already have 501(c)(3) status at the time of application.
	What are the minimum requirements an education agency must meet to apply for the grant?	Education agencies must have 501(c)(3) status at the time of application submission and proposals can only serve residents of Cook County.
	Are hospitals that are 501(c)(3)s eligible to apply for this grant?	Yes, if the hospital is a registered 501(c)(3) at the time of submission.
	Are safety net hospitals that are 501(c)(3) eligible to apply to this grant?	Yes, if the safety net hospital is a registered 501(c)3 at the time of submission.
	How should 501(c)(3) hospitals that don't fit into the community-based organization or FQHC categories categorize themselves in the application?	Organizations that are 501(c)(3) entities and do not clearly match one of the other eligible organization types can indicate that they are 501(c)(3) organizations and provide any additional details in the first section of the application.
	Can for-profit CBOs apply?	No, though for-profit organizations can be partners to lead applicants that are 501(c)(3) organizations. We value the work that all community-based organizations are doing, but for-profit organizations cannot be lead applicants for this grant opportunity.
	Can for-profit mental health practices apply?	For-profit entities can apply as partners to non-profit organizations where the non-profit serves as the primary applicant.

Category	Question	Response
Eligibility – Organization Type/ Service Line (continued)	Can an organization that applied to the previous ARPA funded Building Healthy Communities grant apply to this opportunity?	Yes, previous Building Healthy Communities grant applicants and recipients may apply for this funding opportunity. Applicants are responsible for coordinating funding from multiple sources and must be able to delineate which grants are being used to cover which expenses. As part of their application, these organizations should clearly define how the scope of work for this Open Call differs from the scope of work covered by previous funding.
	Does having received American Rescue Plan funds through other local agencies precludes us from applying?	Organizations that have previously received American Rescue Plan Act (ARPA) funding, as well as other government funding, are eligible to apply.
	Are start-up nonprofits that are still in the process of hiring and developing programs eligible?	Yes, if the center is a registered 501(c)(3) at the time of submission. However, the organization will need to demonstrate how they qualify in the application.
	Does the organization need to have past financials/track record in order to apply?	No, as long as the organization is 501(c)(3) at the time of the application they are eligible. However, the organization will need to demonstrate how they qualify in the application.
	Can an organization be eligible for funding if the project is focused on providing trainings on a variety of topics including mental health, LGBTQ+ health, substance use prevention, etc.?	Yes, if the center is a registered 501(c)(3) at the time of submission. However, the organization will need to demonstrate how they qualify for the strategy they are applying for in the application.
	Are CMHCs that are part of a health system with acute care hospitals and an outpatient clinic network eligible to apply?	Yes, if the CMHC is a registered 501(c)(3) at the time of submission.
	Does the organization have to be a 501(c)(3) registered or just a non-profit that is 501(c)(3) eligible?	The organization must be registered as a 501(c)(3) at the time of submission.
	Are community mental health centers that are part of a health system with multiple acute care hospitals and an outpatient clinic network eligible to submit an application?	Community mental health centers are eligible to submit an application.
	Will we need a sam.gov account?	Applicants do not need a sam.gov account at the time of applying, but all awarded entities must have an active Unique Entity ID (formerly DUNS number) through sam.gov.

Eligibility – Organization Type/	Do we need a CAGE number?	Applicants do not need a CAGE number, but all awarded entities must have an active Unique Entity ID (formerly DUNS number) through sam.gov.
Service Line (continued)	Are Libraries eligible for this grant?	If the library is a 501(c)(3) at the time of submission, it is eligible.
	Are we eligible for the Stronger Together Open Call as a youth development agency that teaches digital media arts workshops in schools (during and after school)?	Please check if your agency falls under the eligibility criteria listed on https://cookcountyhealth.org/strongertogether/ - if after reviewing the list you are still unsure, please feel free to follow up with additional information on your agency so we can help make the determination.
	Our health system is a 501(c)3 with multiple CMHC locations and other BH outpatient provider sites and eligible to submit an application. What is the Eligible Applicant category, we should use - community health center or community-based organization?	You can select 501(c)3 or community health center.
	I am interested in applying for the Stronger Together Open Call, but would need to apply under fiscal sponsorship. Do you have a list of fiscal sponsors that you partner with?	Please follow our guidance regarding applying for this open call as a primary applicant. All applicants will have to follow our applicant eligibility criteria listed in the information packet.
	Prior to completing the Call Application, we are wanting to confirm with you all if we as RUSH University Medical Center could apply, or if not, as the <u>Center to Transform Health</u> and <u>Housing</u> within RUSH?	Either RUSH University Medical Center or the Center to Transform Health and Housing can apply to the Stronger Together open call.
	Can a 501(c)(3) entity have a for-profit entity as a partner as part of the program design?	Yes, organizations that are not 501(c)(3)s may partner with an eligible organization that serves as the lead applicant.
Eligibility – Partnerships	Can two non-profits 501(c)3 partner as one entity with a wider range of expertise apply as one with one leading and primary organization?	Yes, we encourage collaborations. Please note that the lead applicant must be a 501(c)(3) or other eligible organization at the time of submission.
	If an organization is part of a collaborative application under one strategy, can they also submit a separate application for a different project within the same strategy?	Yes, if each organization only serves as the lead applicant for one application per strategy. An organization can serve as a partner on one application and the lead applicant on a separate application under the same strategy.

Category	Question	Response
Eligibility – Partnerships (continued)	Can one organization apply to be the lead for two different strategies?	Yes, each organization can serve as the lead applicant once per strategy. However, they will only be eligible to be awarded as the lead for one strategy.
Liigibility – Faitherships (continueu)	Can organizations use contractors to do part of their project, including clinical work?	Yes, organizations can bring on contractors to complete part of their project. Applicants should explain the scope of work and procurement method for contractors.
	If we are applying as co-leads, do we still have to pick one agency as the main contact?	Yes, each application should have one designated lead applicant. Applications with multiple co-leads should describe the respective roles and responsibilities of each organization and identify only one organization as the lead applicant for the purpose of the application.
	Do we need to submit letters of support/commitment along with the grant application?	No, letters of support or commitment from partner organizations are not required. The only documents reviewers for this grant will consider are the Application, Work Plan, and Budget templates provided. Please do not attach or submit additional documents.
	Does each partner have to be a 501(c)3?	No, only the lead applicant must be a 501(c)(3) or other eligible organization at the time of submission.
	Can public schools be considered partners in a proposal for school-based therapy?	Yes, public schools can be considered partners in a proposal for school-based therapy.
	Is it appropriate for a collaborative to apply collectively, or should it be with one primary organization and subcontracts?	The collaborative should pick one organization to serve as the lead applicant and identify the other organizations/partners and their respective roles in Section B of the application.
	Are partners required?	No, partners are not required.
	Can a collaborative of agencies use a local unit of government as a fiscal agent?	Local units of government can be a partner but not a lead under this Open Call.
	In a collaboration, if the lead organization is younger than its partners, does that make a difference?	No, the lead organization can be younger than its partners.
	Do we list partners that we collaborate with in our work even if they are not a coapplicant?	Yes, please list partners you plan to work with and note what roles and responsibilities they cover.
	Does there need to be a signed agreement or MOU with any partners?	There does not need to be signed agreements or MOUs with partners at the time of submission.
	Will Cook County connect the recipients of the grants together? So that we can see how we could work together and be stronger together instead of isolated projects?	The Office of Behavioral Health will facilitate partner networks where partners can connect with peers, share experiences, align efforts, and learn from each other.

Eligibility – Partnerships (continued)	Upon being selected for funding, can an organization still negotiate and add relevant partnerships in addition to those listed in its initial proposal?	Subrecipients may add additional partners with approval from the Office of Behavioral Health if need. However, the total budget proposed in the application cannot change.
Eligibility – Geographic Scope/ Population	If we do not intend to serve the listed Priority Communities, can we still apply? Are grants being prioritized to the communities listed?	If your work would serve Cook County residents you may apply. Grants are being prioritized based on the communities they serve. The Priority Populations and Communities list notes groups that are more vulnerable, are at higher risk, or harder to reach, but may not include all eligible residents in need of services. Please highlight the need(s) in the communities/ populations you would serve in your application.
	Is this grant solely for Cook County?	Yes, this grant can only serve residents of Cook County.
	Are subset populations eligible?	Yes, organizations serving subset populations of Cook County may apply. Please highlight the need(s) in the communities/populations you would serve in your application.
	Is a program eligible if it serves primarily, though not exclusively, Cook County residents?	This grant can only serve residents of Cook County.
	On page 10 of the RFP, one of the priority communities is listed as "Cragin." Is this supposed to be Belmont Cragin?	Yes, "Cragin" refers to "Belmont Cragin."
	Are listed priority communities in order?	The priority communities are listed in order of highest Social Vulnerability Index (SVI).
	Are students of a higher education institution in Cook County eligible even if their permanent address is outside of Cook County?	Yes, higher education institutions within Cook County are eligible to provide programs and services to students.
	The Priority Populations reached has an "Other" section. Would victims of domestic violence living in a DV shelter be eligible? The shelter is not in a priority population neighborhood, but the clients are primarily low income, Latinx, and come from throughout the city.	Yes, victims of domestic violence living in a domestic violence shelter are eligible. Please be sure to describe the clients/population you are serving under the "Other" Priority Populations Reached section.

Category	Question	Response
	Does the community area "Douglas East Side" refer to the Douglas community area?	Yes, "Douglas East Side" refers to the Douglas community area.
Eligibility – Geographic Scope/ Population (continued)	Is there an age range we should be following for any of the specific strategies?	The age range depends on the type of program. For example, a program that serves youth and family could be ages 0-24, while programs for adults and older adults could be 18 and older.
,	If our organization serves all of Cook County, is it okay to select every community listed under the 'Priority Populations Reached?'	Yes, if the organization serves all of Cook County, they can select each community.
	What is the anticipated program period?	We expect the program period to start on September 1, 2024. The program end date will be November 30, 2026.
Grant Application – Timeline/ Project Period	How should we document the timeline for participant intake and treatment?	Applicants should identify and describe timeline phases, milestones, and deadlines that are most relevant for their program. Some phases may be ongoing for most of the program; applicants can use the Comments section of the Work Plan to provide any context needed for grant reviewers and funders to understand the process for participants.
	Does the timeline need to be for 3 years, or can there be different goals on each year?	All goals and objectives should be clearly illustrated in the program proposal and workplan.
	If we are needing to hire additional staff how much time will we have to hire and train?	Organizations should allocate a reasonable and realistic amount of time to hire and train staff.
Grant Application – Outcomes, Metrics, and Reporting	Are there outcome measurements included in the grant offering application, and are there other key outcomes that are required to fulfill? Is there a list of required metrics applicants can look at?	Yes, please see page 15 of the "Stronger Together Open Call Information Packet" PDF under Deliverables and Obligations of Awards for the deliverables and metrics. Please note that while required metrics are already determined, grant applicants should identify program-specific outcomes they will report on in their Work Plan.
	Is the reporting cadence the same for the CCDPH BHC Open Call grant programs or can the provider propose their own reporting cycle?	The reporting cadence is the same; the US Treasury and County require grant recipients to submit metrics monthly to the Office of Behavioral Health at Cook County Health. Recipients will have 30 days after the end of each month to report data from the month before. For example, recipients will submit metrics for September 2024 by October 31, 2024.
	Can the people served (outcomes) grow over time as the program gains momentum?	Yes, the number of people served can increase over the project lifetime. Applicants should identify outcomes that can capture any project growth.

Grant Application – Outcomes, Metrics, and Reporting (continued)	Apart from financial reporting, can you please confirm if the following table, also from Page 16, is the only set of predetermined metrics that will be required for reporting? Are there any other defined and required reporting metrics for the funding source or the Office of Behavioral Health?	Subrecipients will also be expected to submit treasury-required and county equity-level metrics. These metrics will be built out during the program standup phase.
	In order to meet all the reporting requirements that you have outlined, grantees will need to report on the goals and objectives they proposed as well as the Treasury indices and indices given by the county. Is that correct?	Yes, the full reporting requirements are reporting on 1) Treasury-required metrics, 2) County Equity metrics, and 3) Program metrics agreed upon between Cook County and the grant awardees. Grant awardees will have a chance to revisit the metrics (outcomes) they submitted in their application and work with the County to determine the final list to report on.
Grant Application – Budget	We noticed an error in the funding track and strategy section in the budget and budget narrative template. Can you please correct this?	Thank you for this notification. The corrected budget and budget narrative template has been uploaded to the Stronger Together website Stronger Together: Building a More Equitable Behavioral Health System - Cook County Health .
	How do we identify Year 1 and so on for budgeting purposes?	Provided the program launches as planned, year one will be from September 1, 2024 – November 30, 2024. Subsequent years will be from December 1 – November 30.
	Please explain the difference between the two tracks	The only difference between the two tracks is how much total funding is awarded. The application and program requirements are the same.
	Is the amount of the award the same for each of the years (e.g., \$500,000 / year)?	Each funding track indicates the total amount available over the duration of the program (anticipated to begin September 1, 2024, and to end November 30, 2026). Each year can have different total allocations and different allocations between budget categories.
	Will grant awardees have opportunities to rebudget during the program?	Organizations should provide budgets that are as accurate as possible. Cook County Health recognizes program needs may change over time., and there will be case-by-case opportunities to adjust the budgets. Organizations will be asked to justify any changes.

Grant Application – Budget (continued)	Will funding be reimbursement based?	Funding will primarily be advancement-based. Grant awardees can request advance payments between 25% to 50% of their estimated budget per fiscal year. Grant recipients will complete a Risk Assessment that will dictate the exact terms for advancements. As needed, recipients can also receive funds through reimbursements.
	Do organizations need to plan reserves for a 45-day-payments?	Organizations should plan for 4-6 week payments.
	Can funds be used on capital expenses?	Funds from this grant cannot be used for the purchase or improvement of land or purchase, improvement, or construction of a building. Please see the "Stronger Together Open Call Information Packet" PDF for a list of eligible and ineligible expenses.
	Are food and beverages eligible expenses?	Yes, food and beverages are eligible if tied to specific programming events or needs.
	Are hiring bonuses an eligible expense?	No, hiring bonuses are not eligible expenses for this specific grant opportunity.
	Is rent an eligible expense?	Yes, rent is an eligible expense under other direct costs if directly related to program services.
	Are consultant fees paid to a grants firm that will be tracking and reporting for this grant allowable as budget line items?	Yes, consultant fees are an eligible expense for this grant opportunity.
	Are matching funds required for this grant opportunity?	No, matching funds is not required.
	Is there a per-participant/recipient cost range or limit for services?	No, there is not limit on per-participant expenses if the proposal includes an explanation of the cost, likely in the Budget Narrative.
	Is there a section in the budget to describe in-kind contributions?	No, the budget template is specific to the funding you will be receiving for this grant opportunity.
	What category of the budget template do cost associated with other partner organizations fall?	Costs related to partners in this project will be included in the budget template under Consultants and Contractors

Grant Application – Budget (continued)	What counts as indirect costs? How should we calculate that?	Indirect costs are costs that cannot be identified for a specific grant award, service, or activity of an organization, but are incurred as the result of multiple grant awards, services, or activities (see 2 CFR 200.56). Applicants that already have an established Negotiated Indirect Cost Rate (NICRA) with a federal agency for the upcoming fiscal year should use that rate. All other applicants can allocate up to 10% of their modified total direct costs (MTDC) over the project lifetime to indirect costs. MTDC are the sum of direct costs from salaries, wages, benefits, materials, supplies, training, marketing, travel, consultants, contractors, beneficiaries, up to \$25,000 of each subaward to partner organizations, and other direct costs. MTDC excludes rent, utilities, phone and internet, technology and equipment, program participant costs, and any unspecified administrative costs—these are eligible direct expenses but cannot be counted in the sum used to calculate indirect costs.
	Can you apply for both levels, \$500,000 and \$1,000,000?	Organizations can be the lead applicant once per strategy and must select one funding track per application. Please see the questions in the Eligibility – Partnerships section and Strategy-specific sections for more information.
	Can organizations submit more than one application for the same category, one for the \$500,000 track and one for the \$1,000,000 track, if they are not the lead on both applications?	Organizations can be part of multiple applications to the same strategy where each application is for a different funding track. Applicants should note that a key goal of this funding opportunity is to "improve equitable distribution of resources," as noted in the Use and Availability of Funding section of the "Stronger Together Open Call Information Packet" PDF. Strong applications will clearly describe why each partner organization is uniquely positioned to fulfill the program goals and mission and advance the selected Strategy.
	Is there a cap on salaries?	No, but costs must be reasonable to the scope of the project and justified in the Budget Narrative.
	Is there fiscal agent that handles the flow of funding for this project?	Grant recipients will work directly with the Office of Behavioral Health at Cook County Health on project implementation and all fiscal processes.
	Can an organization hire an employee that will be responsible for tracking and reporting program metrics?	Yes, an organization can hire an employee that will be responsible for tracking and reporting program metrics.

Category	Question	Response
Grant Application Budget	Can funding be used for marketing, hiring additional therapists, expanding, or securing larger facilities, etc.?	The eligible uses are detailed in the required Budget and Budget Narrative document for the application.
Grant Application – Budget (continued)	Are equipment purchases allowed in the budget?	Yes, equipment purchases are allowed in the budget. In the budget narrative, explain how the equipment is necessary for the success of the project. Please see the budget category descriptions under budget and budget narrative document.
	Where is technology addressed in the budget form?	You can list technology used specifically for your program under the "equipment" budget category.
	Can organizations charge towards facility expenses?	Yes, if the facility expense is used directly for the funded program.
	Does the budget cover capital expenditures?	Yes, the budget covers capital expenditures. Examples of capital improvements and construction include Institutional Equipment, Computer and Tech Equipment, Office Furniture, Vehicle Equipment, etc.
	How are funds disbursed if you enter an application with a community partner?	Funds will be disbursed to the lead applicant.
	Are marketing, outreach, and translation eligible expenses?	Yes, marketing, outreach, and translation are eligible expenses.
	Can we pay youth as apprentices and interns for programs during the summer/school breaks and for opportunity youth not in school and under the age of 26?	Yes, you can pay youth as apprentices and interns for programs during the summer/school breaks and for opportunity youth not in school and under the age of 26.
